

TERMS AND CONDITIONS

1. Check-in/out

Check-in: 2:00PM

Check-out: 11:30AM

2. Payment

All hotels accept the most common credit/debit cards. The hotel is not obliged to accept foreign currency, vouchers, cheques or credit/debit cards unless the hotel has volunteered to do so.

3. Cancellation

Unless otherwise agreed at the time of reservation, unless the rate confirmed or the reservation period includes special terms, the room can be cancelled until 5 day prior to arrival without a fee.
